Watchdog on Ministry Abuse (investigating religious fraud)--The Foundation is one of the nation's leading religious-media "watchdogs". Information requests are met regularly from local, regional, national and international media outlets as well as various government agencies--including the Senate Finance Committee. The Foundation maintains an 800-number help line and an online questionnaire for victims of televangelists. We have worked with organizations such as Prime-Time Live, Inside Edition, A Current Affair, ABC 20/20, CBS Sixty Minutes, ESPN, and hundreds of newspapers, magazines and talk shows have used our services. The Foundation maintains a nationally recognized video archive of televangelism broadcasts, a print-media clip file and extensive direct-mail files on several hundred televangelists and other ministries. Donor Advocacy: Our website facilitates the information needs of donors and victims of religious ministries.

Service Corps--specifically started as a practical resource for our community and for providing an on-going work rehabilitation program for the poor and homeless we care for. It now includes community service restitution for persons who are performing court-ordered hourly restitution--we provide a place for these persons to work off their mandatory hours.

Experiential Learning/Bible Study--Foundation members experience an important part of their faith by participating in the feasts and fasts outlined in the bible--Rosh Hashanna, Yom Kippur, Tabernacles, Hanukkah, Purim, Passover, Pentecost, the Sabbath meals and the fasts. Bible Study--The Foundation sponsors several home churches in an attempt to recapture the first-century Christianity experience of community and the Christian meaning of the feasts. During July 2010, all activities relating to this program service were directly passed on to the Community on Columbia Church. As a result, the figures here include all revenue and expenses for the first half of the year only. It is no longer a function of the Trinity Foundation.
