When all was said and done, we had made a \$115 adjustment to the accumulated depreciation account in order to balance (\$907 - \$115 = \$792). At year end we had \$2,282 on hand in securities and a negative balance of -\$5,324 in our bank account due to a number of outstanding checks leaving us with a "negative" cash balance of -\$3,042. Many of those checks may or may not ever be honored; regardless, we cannot enter an amount less than "-0-" per limitations of the form 990EZ program and per instructions vis-a-vis the IRS.

Form 990-EZ, Part II, Line 26 - loans from officers: Additional loans adding up to \$24,766 were made by Foundation president Anthony to continue the work of the foundation (now owed to Anthony=\$105,521). Also, in 2012, a \$67,000 lien owed to Rutledge on Foundation property was passed along to the Community on Columbia Church along with the property itself--reducing both assets and liabilities somewhat. Another \$50,000 loan to the foundation from Gene Phillips dating back to 1998 is still outstanding (total loans \$155,521). Outstanding checks left us with an overall "negative" cash balance of -\$3,042 (checking and securities accounts combined). As mentioned previously, we entered "-0-" per limitations of the form 990EZ program and per instructions vis-a-vis the IRS.
