EAGLE MOUNTAIN INTERNATIONAL CHURCH, INC. pursuant to the provisions of Article 4.06 of the Texas Non-Profit Corporation Act, hereby adopts these Restated Articles of Incorporation which accurately copy the Articles of Incorporation and all amendments thereto that are in effect to date and as further amended by such Restated Articles of Incorporation, and this instrument contains no other change in any provision thereof. Such Restated Articles of Incorporation more clearly express the religious purposes of the Non-Profit Corporation, and reflect more specifically the Non-Profit exempt purposes of the Corporation since its inception.
- 2. The Restated Articles of Incorporation were adopted in the following manner:

The original Articles of Incorporation of EAGLE MOUNTAIN INTERNATIONAL CHURCH, INC. were filed in the office of the Secretary of State of the State of Texas, on the 23rd day of May, 1968, pursuant to the Texas Non-Profit Corporation Act of the State of Texas, and were amended on June 8, 1978; May 30, 1979; March 24, 1981; November 10, 1981; December 13, 1983; and June 13, 1986, and the above described and named Board of Trustees and Members of EAGLE MOUNTAIN INTERNATIONAL CHURCH, INC. hereby represent and state to said Secretary of State of the State of Texas, that no shares of stock, representing any ownership interest in said EAGLE MOUNTAIN INTERNATIONAL CHURCH, INC. have been issued. The Restated Articles of Incorporation of EAGLE MOUNTAIN INTERNATIONAL CHURCH, INC. filed on the 13th day of June, 1986 in the office of the Secretary of State of the State of Texas, are hereby restated as follows, by substituting the following Articles in their place, in their entirety, to-writ:

RESTATED ARTICLES OF INCORPORATION

<u>ARTICLE I</u>

The name of this corporation shall be EAGLE MOUNTAIN INTERNATIONAL CHURCH, INC. The corporation may also be known by a shortened form of the above-style, and may be represented by the shorter form to the public, to-wit: EAGLE MOUNTAIN CHURCH. The corporation may also be known by a shortened form of the above-style, and may be represented by the shorter form to the public, to-wit: KENNETH COPELAND MINISTRIES.

ARTICLE II

- A. This corporation is a not-for-profit corporation and is not organized for the private gain of any person. It is organized under the Non-Profit Corporation Act exclusively for religious purposes.
- B. The specific purpose for which this corporation is formed is to further the Gospel of the Lord Jesus Christ, and to engage in any lawful act or activity for which corporations may be organized under the Non-Profit Corporation Act.
- C. The duration of the corporation is perpetual.
- D. The corporation shall not have capital stock.
- E. The corporation elects to have no members. Any action which would otherwise require a vote of members shall require only a vote of the Board of Directors, and no meeting or vote of members shall be required for this Corporation, any provision of the Articles of Incorporation of this Corporation or the Bylaws of the corporation to the contrary notwithstanding.
- F. The corporation, a church, elects the ecclesiastical form of church government, whereby the Board of Directors shall be the highest ecclesiastical tribunal of the church, and shall be the final arbiter of all questions of church doctrine, church discipline, church property, church policy, and church polity of every kind and nature whatsoever, and the Board of Directors in its deliberations as the ecclesiastical government of the church shall use as its sole and final authority and standard the Holy Scriptures, Old and New Testaments, King James Version.

ARTICLE III

ARTICLE IV

The Board of Directors shall be at least three (3) in number.

ARTICLE Y

- A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, (the "Code").
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- C. The property of the Corporation is irrevocably dedicated to nonprofit religious purposes. No part of the net earnings of the Corporation shall inure to the benefit of its directors, officers, or to any other individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments in the furtherance of the nonprofit religious purposes of the Corporation.

D. Upon the winding up and dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all the debts, obligations, and liabilities of the Corporation, distribute the remaining assets of the Corporation exclusively for the nonprofit religious purposes of the Corporation in such manner as the Board of Directors shall in its sole discretion determine, or shall distribute the remaining assets of the Corporation to such organization or organizations which are organized and operated exclusively for the nonprofit religious purposes of the Corporation and which are tax exempt under Section 501(c)(3) of the Code, as the Board of Directors in its sole discretion shall determine.

E. In furtherance of its religious nonprofit tax-exempt purposes, the Corporation shall have the following powers and authority:

- (a) To do all acts, including ordination of ministers of the Gospel, perform all functions, and carry on all activities permitted by the nonprofit corporation laws of the State of Texas or of any other State in which the Corporation is qualified to act.
- (b) To have and exercise all powers and rights enjoyed by corporations generally in the State of Texas, and in any State in which the Corporation is qualified to act, as long as the exercise of such powers is not specifically prohibited for nonprofit religious corporations.
- (c) To use all media, whether now known or hereafter discovered, including, but not limited to, print, television, and radio.
- (d) To exercise such incidental powers as may reasonably be necessary to carry out the purposes for which the Corporation is established, provided that such incidental powers shall be exercised in a manner consistent with its tax-exempt status as a religious organization as set forth in Section 501(c)(3) of the Code.
- (e) Notwithstanding any other provisions of the Articles of Incorporation or the Bylaws, the Corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the nonprofit religious purposes of the Corporation, and the Corporation shall not carry on any activity not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3)

of the Code, or under the corresponding section of any future United States revenue taw; or (b) by a corporation, contributions to which are deductible under 170(b)(1)(A)(i) of the Code, or the corresponding section of any future United States revenue law.

This action was taken by unanimous written consent of all members having voting rights in respect thereof, and of the Board of Directors of the corporation in accordance with the appropriate statutes of the State of TEXAS requiring no notice and received the vote of all the Members and the Board of Directors in office.




