We believe The Trinity Foundation meets the facts and circumstances test for 2019 for the following reasons. In 2019 we received an large, unexpected, irregular donation that put the Trinity Foundation below the 33 1/3% rule. The Trinity Foundation consitently has a comparitively larger number of small amount donors. This one-time donation is not reflective of an average year and we anticipate returning to the regular 33 1/3% threshold soon. The Trinity Foundation maintains a board comprised predominantly of independent board members who have an interest in exposing religious fraud.

Our investigations are available to the public and we receive frequent calls from members of the public who have been victims of religious fraud asking us to investigate a large number of religious organisations. We have broad solicitation of revenue on our website and on social media (Facebook). We have online support with positive public comments and specifically have a great deal of public support on our YouTube channel that focuses on exposing religious fraud and excess expenditures. We also search and apply for grants to increase revenue when available.
