You are further commanded NOT to pay to Defendant any debt or to deliver to Defendant any effects, pending further order of this Court. Herein fail not, but make due answer as the law directs.

To WORLD HEALING CENTER CHURCH, INC., d/b/a Benny Hill Ministries,
Defendant:

Your money or property has been frozen or seized ("garnished") because PRINTMPRO, LTD, d/b/a PrintMailPro, (the "Garnishor") has filed a garnishment proceeding. That means they are trying to get your money or property from FROST BANK, (the "Garnishee"), the company or person who has it, to pay a debt you owe.

If you are an individual (not a company), your money or property may be protected ("exempt") from garnishment under federal or state law. Under Texas Rule of Civil Procedure 679b, the Garnishor must send you in the next few days a "Notice of Protected Property Rights" approved by the Supreme Court. Read that notice carefully for more information on what property can be protected and how to get your protected money or property back. You can ask the court to get your money or property back by turning in ("filing") the "Protected Property Claim Form" that will be sent with the Notice of Protected Property Rights.

You may also file a "motion to dissolve" or "motion to modify" this writ of garnishment with the court because your money or property is exempt from garnishment. You can also get your money back if you file a "replevy bond," which is cash or other security in an amount set by the court.
