BEFORE ME, the undersigned authority, on this day personally appeared OLE ANTHONY, known to me to be the person whose name is subscribed hereto, and who upon his oath deposed and stated as follows:

- 1. My Name is Ole Anthony. I am over the age of eighteen years and I am fully capable of making this affidavit. I am a resident of the State of Texas. I have personal knowledge of all facts stated herein, which are true and correct.
- 2. I am president of Trinity Foundation, Inc., and am the Manager and Senior Investigator of a Texas Private Investigation Agency (Texas License number A07586 issued to Trinity Foundation, Inc.).
- 3. Trinity Foundation has been monitoring the activities of Trinity Broadcasting Network (TBN) since the early 1990s.
- 4. We began working on the TBN story with Mr. William Lobdell, staff writer of the Los Angeles Times newspaper in December 2001 or January 2002. He came to our Dallas, Texas headquarters in January 2002 and again during the summer of 2003 in order to interview me and to examine the information we had collected in the course of our investigation of TBN.
- 5. I told Mr. Lobdell that I had been receiving reports of Paul Crouch's alleged homosexual activities since 1998.
- 6. Our informants have told us that Mr. Crouch has had at least 3 homosexual affairs and has paid out hundreds of thousands of dollars in hush money. We were told that one of those affairs was with a man named Enoch Lonnie Ford. We have been told that another affair was with a man whose last name is Henderson and that he was a member of John Jacobs' Power Team. The alleged third affair was with a man whose name is unknown to us at this time.
- 7. We have an informant who was close to Paul Crouch who told us that Paul is an episodic drunk and may well be an alcoholic. He told us he had personally picked Paul up in the restroom of a bar, when he found Mr. Crouch lying on the restroom floor passed out in his own vomit, and carried him out to his own car.
- 8. We have been told that it is during these times of intense inebriation that Paul Crouch experiences uncontrollable homosexual urges.
- 9. Mario Licciardello hired us to assist in his defense of legal action televangelist Benny Hinn had initiated against him. Licciardello had been hired by Hinn to investigate corruption within Benny Hinn Ministries. We furnished the

Licciardello deposition given in that case to Mr. Lobdell. The significant pages are attached as Exhibit A.

- 10. The information we have received concerning Paul Crouch's homosexual activities is consistent with the portion of Mario Licciardello's deposition wherein he related Benny Hinn's description of how Paul Crouch confessed to him his affair with Lonnie Ford and said his excuse was that he (Paul Crouch) was drunk.
- 11. We were told that Matt Crouch found out about his father's homosexuality and was so devastated that he called several people he respected (including Benny Hinn, Jack Hayford, and David Middlebrook) to ask them what he should do.
- 12. One informant told us that Jan Crouch knows about Paul's homosexual urges and that that is one of the reasons she and Paul have not lived together as man and wife for over 15 years. Reportedly, they have remained married only to maintain the appearance of a Godly couple in order to save their television network, though they normally live in separate domiciles.
- 13. We gave Mr. Lobdell the name of Lonnie Ford almost 3 years ago. At that time we did not know his first name was Enoch. It was not until we made trash runs at the law firm of a TBN attorney, Dennis Brewer, that we discovered the two letters referencing a lawsuit and his full name. We also gave Mr. Lobdell the Dennis Brewer letters that he quoted in his September 12, 2004 Los Angeles Times story. Copies of those letters are attached as Exhibit B. Other relevant documents that were furnished to Mr. Lobdell are listed and attached in Exhibit C.
- 14. We asked Mr. Lobdell not to identify us as the source in the early stages of his story because we did not want to compromise our access to Mr. Brewer's trash as it was a key source of information for several other of our ongoing investigations. Mr. Brewer's move to a secure office facility has obviated our need for anonymity as Mr. Lobdell's source.
- 15. My fervent prayer for Paul Crouch is that he would step down from his position as head of TBN, seek Godly therapy and help for his addictions and be reconciled with his wife. It is my hope that an appropriate authority would appoint an interim leader and an independent, non-family, board of directors with real authority to run the network. The Trinity Broadcasting Network was built with donor funds and there must be real accountability for this multi-billion dollar non-profit enterprise.
